E-RATE WORKSHOPS

BID LIKE AN AUDITOR IS WATCHING: PREPARING FOR USAC BIDDING PORTAL & E-RATE COMPLIANCE REVIEWS

Attendees are e The USAC competitive bidding portal is coming whether we like it or not! This portal will introduce a new level of visibility into the E-Rate procurement process. With bids, evaluations, contracts, and supporting documentation becoming increasingly centralized and accessible to USAC and the FCC, applicants should prepare for a future where compliance is demonstrated—not assumed. Join us as we discuss what is currently known about the portal, review common audit and review types, explore frequent findings, and share practical strategies for maintaining defensible procurement records. Whether you're an E-Rate veteran or new to the program, you'll leave with tools and best practices to help your organization remain compliant from bid opening through final audit.

E-RATE INVOICING & SAM.GOV

Navigate the E-Rate invoicing process with clarity and confidence in this practical, step-by-step session. Participants will gain a clear understanding of the differences between BEAR and SPI invoicing methods, key submission deadlines, and common mistakes that can delay reimbursement. The session also covers SAM.gov registration and maintenance requirements to ensure accounts remain active and compliant. Attendees will leave with actionable strategies to streamline invoicing workflows, avoid costly errors, and ensure timely receipt of E-Rate funds.

Joseph Wender will discuss and give insight on the current state of the Universal Service Fund and E-Rate, which will cover how Congress, the courts and the Commission (FCC) are working to both strengthen and weaken the E-Rate Program.

ABOUT JOSEPH WENDER

Joseph Wender serves as Executive Director of the Schools, Health, and Libraries Broadband Coalition (SHLB), where he leads efforts to ensure that every school, library, and healthcare provider has access to affordable, high-speed broadband. He previously served as Director of the Capital Projects Fund, overseeing the \$10 billion program at the U.S. Department of the Treasury and helping to ensure that all communities have access to modern internet access. He also worked for 13 years on Capitol Hill, including as Senator Ed Markey's Senior Policy Advisor, where he led a team covering a wide range of issues including telecommunications and infrastructure. Wender additionally worked as then-Representative Markey's Legislative Director. Prior to working for Markey, Wender served as Counsel for the House Transportation and Infrastructure Committee. He received his BA from Wesleyan University and graduated magna cum laude from Harvard Law School.
